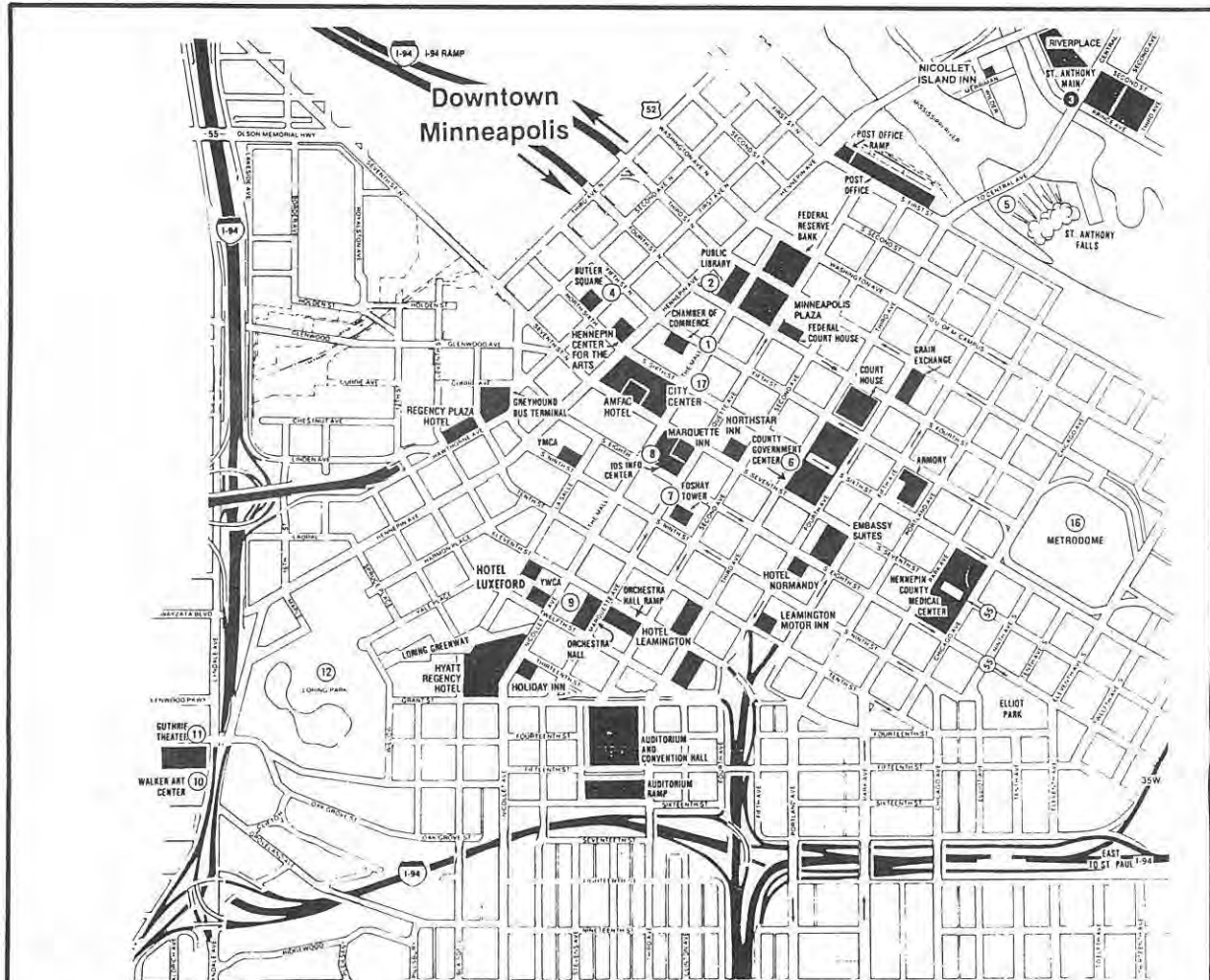

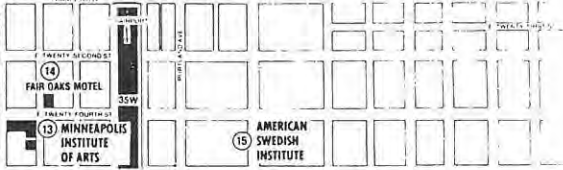

### Points of Interest Downtown

1. **Nicollet Mall** Nation's longest downtown pedestrian stroll-way flanked by trees, flowers, benches and fountains—the heart of the shopping district. Perfect for leisure walk in summer and a holiday spectacle of lights during the winter months.
2. **Minneapolis Public Library and Information Center** John Rood's sculpture "The Scroll" faces the main entrance on the Mall. Exhibits in the lobby feature topics of interest, changed every six weeks. Also visit the Planetarium in the Library.
3. **St. Anthony Main/Riverplace . . . on the river**, in the historic heart of Minneapolis. It is a stunning collection of distinctive shops and restaurants.
4. **Butler Square** Old massive warehouse renovated with interesting shops, restaurants and offices.
5. **Upper St. Anthony Lock & Dam** See historic St. Anthony Falls, where Minneapolis was founded and which supplied power for early lumber and flour mills. Tour the Federal Lock & Dam, start of navigation of Mississippi River.
6. **Minneapolis City Hall/Hennepin County Government Center** A dramatic architectural contrast between stately City Hall with a clock larger than "Big Ben" in London and the new modernistic home of County Government.
7. **Foshay Tower** A Minneapolis landmark designed after the Washington Monument. Observation deck on the 31st floor.
8. **IDS Center** Fifty-seven story home of Investors Diversified Services. Star attraction is the Crystal Court with 120-foot ceiling topped by see-thru pyramids and overhanging restaurants.
9. **Orchestra Hall** Exciting downtown Minneapolis home of the world famous Minnesota Orchestra, ranked among the finest concert orchestras in the nation.



10. **Walker Art Center** One of the finest art galleries offering an extensive collection of contemporary art.
11. **Guthrie Theater** World famous repertory theater built by Sir Tyrone Guthrie.
12. **Loring Park** The lake and park in Downtown Minneapolis ideal for strolling and relaxing amid greenery, water and a host of swans and ducks.
13. **Minneapolis Institute of Arts/Children's Theatre Company** A newly expanded museum with paintings and sculptures considered among the finest in the world and CTC, the country's largest professional Children's Theatre.
14. **Hennepin County Historical Society** Elegant mansion displaying items from the early settlers of Hennepin County (Minneapolis).
15. **American Swedish Institute** A 33-room castle-like mansion filled with fine exhibits depicting Minnesota's Scandinavian heritage.
16. **Hubert H. Humphrey Metrodome** A dramatic addition to the downtown skyline. The home of the Minnesota Twins, Minnesota Vikings, Minnesota Strikers and the University of Minnesota Gopher football team.
17. **City Center** A 3-level skylit shopping mall with 3 major restaurants, a fast food court and over 60 unique and exciting shops.

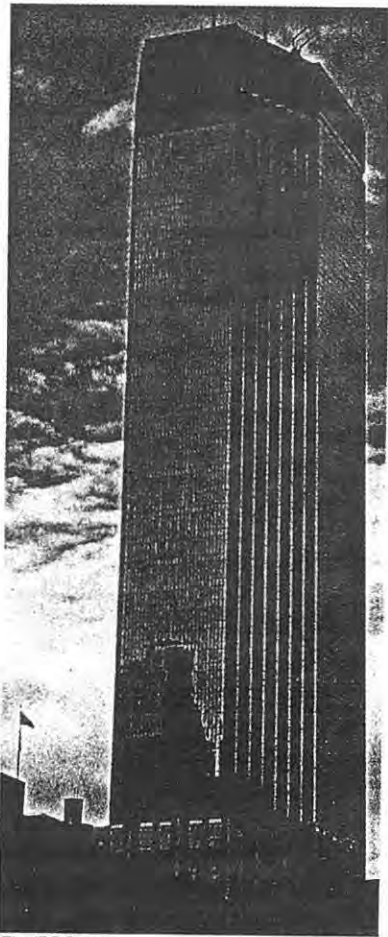

Because of its central location and architect Philip Johnson's dramatic design, this multi-purpose complex is the hub of downtown activity. The Center includes a 57-story office tower—Minneapolis' tallest building—an imposing hotel and three levels of retail stores encircling the "Crystal Court" atrium. All of which is interconnected by an elaborate skyway system.

Minneapolis got its start in skyways back in the early Sixties when several buildings in the financial district were joined for businessmen's convenience. It was a good idea, and it caught on quickly.

Soon skyways were popping up all over—between major department stores, joining apartment complexes and office buildings, connecting parking garages with shopping routes. Currently, more than 20 central city blocks are linked by skyways. Planning and construction of more pedestrian bridges is under way.

With the 1973 addition of IDS Center skyways, the system gained its crown jewel.

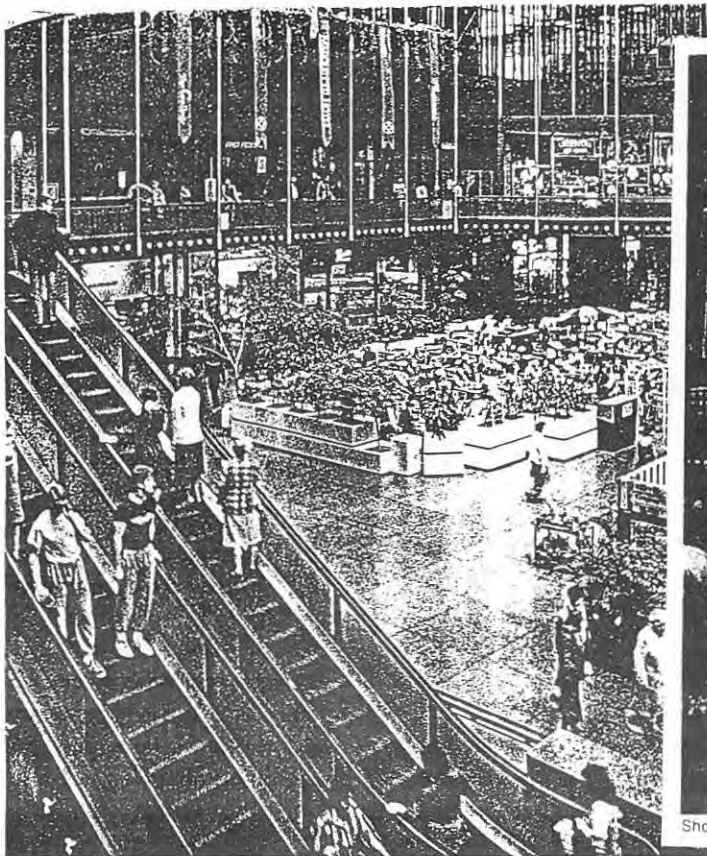

Shopping along the Nicollet Mall area.

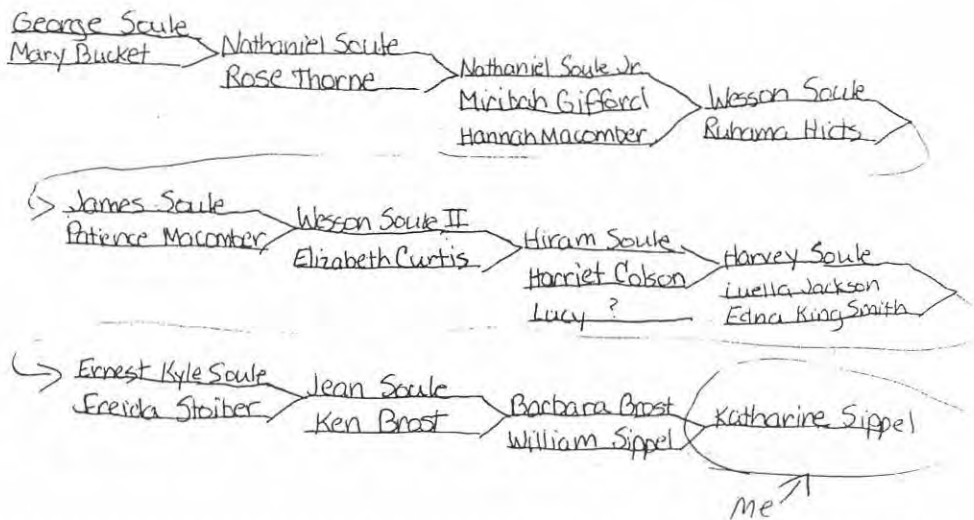

We are searching for the parents of Lydia SOWLE, wife of Isaac GAIGE of Duaneburg, New York. Lydia died between 1810 and 1816, Duaneburg, NY. Children of Isaac and Lydia (SOWLE) GAIGE are: Ruth GAIGE married 2 7th mo 1807 Nathaniel ESTES; Lavinia GAIGE married 29 4th mo 1816 Jedediah SHEARMAN; Mary Gaige, b. 22 8 mo 1798 married Francis HOAG 31 5th mo 1821; d. 3 2nd mo 1857; Patience GAIGE b. 16 2 mo 1797, married 3 4th mo 1823 Samuel QUIMBY; d. 11 3rd mo 1843 (my husband's ancestors); Isaac J. Gaige, b. 1801 married Elizabeth (?). Apparently, Lydia SOWLE GAIGE was of a Quaker family, but married out. Isaac became a Quaker in 1797.

Any help that you can give us will be greatly appreciated. Perhaps someone has a family Bible that will have the record of Lydia SOWLE GAIGE's parents.

MINNEAPOLIS A GOOD PLACE TO VISIT!

Twin Cities make '86 list of top 10 vacation spots

Arthur Frommer is telling people that Minnesota is not just for fishermen anymore.

Culture has helped Minneapolis and St. Paul to earn a place on Frommer's 1986 list of 10 best vacation spots in the world.

That's right, the world.

Frommer, who gained fame with his book, "Europe on \$5 a Day," included the Twin Cities on a list with Alaska; Australia; Buenos Aires, Argentina; the Maldive Islands in the

Indian Ocean; New Mexico; Orlando, Fla.; the Soviet Union; Tanzania, and Vancouver, British Columbia.

The list, called Frommer's Top Spots, was compiled for Citicorp Travelers Checks for its Smart Travelers program, which provides consumer education to tourists. While he's been associated with Citicorp for three years, this is the first year Frommer has publicized a Top 10 list.

Frommer was unavailable for comment Wednesday, but Linda Bachmann, a spokeswoman for

Citicorp, shared the word on why visitors should trade in their tackle boxes for theater boxes.

"Arthur Frommer is in love with the Twin Cities because of the marvelous cultural offerings now available," Bachmann said. "The Twin Cities are no longer merely regarded as a sportsmen's paradise, but now have the distinction of being cultural capitals of the nation ranking second only to New York City."

The Top Spots brochure mentions the Ordway Music Theatre, Guthrie Theater and Pinchas Zukerman and also makes note of the good values to be found in some weekend hotel packages and the abundance of air travel available.

The Minnesota connection apparently is the fruit resulting from a seed planted two years ago when Frommer was invited here for the state's annual tourism

conference. Hank Todd, director of the Minnesota Office of Tourism, remembered Frommer being astounded by the variety and affordability of theater and concerts here.

"People tend to conjure up their own impressions of a place, and to

someone from the East Coast, there's nothing here," Todd said. "Once you visit, you become aware of the depth of things that exist in arts and cultural attractions."

The other nine places are on the list for a variety of reason, Bachmann said, including Alaska's majestic and unspoiled outdoors; Tanzania's safaris with its incomparable wildlife; New Mexico's foreign flavor with native cuisine and local artisans, and the Soviet Union's improved accessibility and tour package bargains.

Dr. Francis Gordon Soule, Jr., a retired physician and officer in the United States Navy, died Thursday 2 January 1986 at the Massachusetts General Hospital in Boston after a brief illness. He had been a Sandwich resident since 1979. He was the husband of Mary Elizabeth (Ragle) Soule, and the son of the late Francis Gordon Soule and Lenora Blanche (Mansfield) Soule of Glen Ridge, New Jersey and Orlando, Florida.

Born in Schenectady, New York, Dr. Soule was a graduate of Glen Ridge High School and of Dartmouth College, class of 1936. He received his medical degree from New York University in 1939 and interned at Mountainside Hospital in Montclair, New Jersey. He later completed post-graduate medical study at the University of Pennsylvania in Philadelphia. He

was a Fellow of the American College of Physicians, a Diplomate of the American Board of Internal Medicine, and a member of the American Medical Association and the Massachusetts Medical Society.

For 24 years, Dr. Soule served on active duty in the Navy Medical Corps, retiring with the rank of Captain. He was at Pearl Harbor when the Japanese attacked. He was Senior Medical Officer aboard the USS Missouri (BB63) during the Korean War. In the late 1950's and early 1960's he was Senior Medical Officer at the U.S. Naval Base, Subic Bay, Philippines. During his last tour of duty, he was Chief of Clinical Services, National Naval Medical Center, Bethesda, Maryland.

Following retirement from the Navy in 1965, Dr. Soule settled with his family in Andover, Massachusetts, becoming director of medical education at the Beverly Hospital. He later assumed this same position at the Lahey Clinic in Boston. For nine years he served as medical director at Phillips Academy, Andover.

In 1979, Dr. Soule retired from the practice of medicine and moved to Sandwich on Cape Cod where he became active in community affairs. He served as Chairman of the Library Building Committee and the School Building Committee, and also as a member of the Town Finance Committee.

Like his father, Dr. Soule also was known as "Frank".

In addition to his wife, Dr. Soule is survived by three sons, John Gordon Soule of Austin, Texas, Richard Mansfield Soule of Sturbridge, Massachusetts, and Robert Ragle Soule of Alexandria, Virginia; three grandchildren; one niece and two nephews; and several cousins.

### Beach Carter Soule

Retired Bay Area businessman Beach Carter Soule, 83, the descendant of a pioneer East Bay family, died Tuesday at Ralph K. Davis Medical Center in San Francisco after a short illness.

Mr. Soule, a third generation Oaklander, was the former president of Soule Gibbs, a food-broker wholesale business in Oakland and San Francisco. The company, of which he was part owner, was dissolved in the mid-1960s. He was also the former president of Nalley's Foods, a wholesale canned food producer now operating in Seattle.

Mr. Soule was a 1921 engineering graduate of the University of California at Berkeley. He was a Navy veteran of World War II.

He was a member of the Pacific Union Club and a member of the Zeta Psi Fraternity.

Mr. Soule's roots in the Bay Area date back to the mid-19th century. His great-grandfather, B. Frank Soule, who came west from St. Louis, was the author of "The Annals of San Francisco," one of the first history books written about the city after the gold rush. The book was published in 1854. His grandfather, Frank Soule, was one of the first full-time engineering professors at the University of California at Berkeley. He joined the campus staff in the mid-1890s.

Mr. Soule's father, Oakland millionaire Beach Carter Soule Sr., was a well-known land developer in Northern California before and after World War II. Some of the family's major holdings were in Forest Hill and downtown Oakland. Many of the family's historic real estate and land holdings have been relinquished.

Mr. Soule is survived by his wife, Lore Soule of San Francisco, and a daughter, Jeanne Soule Dickey of Woodside.

## RECORDING OF FAMILY DATA

By Geraldine Soule Schlosser, Editor

Soule Kindred needs information, especially on families since 1800. We'd like to suggest that you begin with your 6th generation ancestor from George Soule (or your earliest Soule ancestor, if you haven't made the connection to George-1). Fill out a form for that ancestor, and then submit forms for each of your ancestors down to yourself. This is especially important if you descend through a female line; Soule women who marry tend to become lost Soules.

We have been asked to explain how to fill out the form. To help in seeing just how it's done, I've completed a form for my 6th generation ancestor, on page 63 and 64. Let's take a look at how it's done:

(1) The "Generation" space in the upper left corner shows the generation from your immigrant ancestor. Please leave it blank unless you are certain. (I put in "6" because the line is established.)

(2) In the far upper space on the right for "FAMILY", leave it blank if the surname of "Soule Descendant" is SOULE, SOWLE, or variants, because we'll assign a code number for closely related family groups. If the "Soule Descendant" has a different surname, insert the name in the right upper space. (I left it blank because the surname is SOWLE and I don't know the code number.)

(3) The next two lines show the ancestors of the "Soule Descendant" back to George Soule-1. Unless you have an approved Mayflower Lineage or other positive proof, we suggest this be left blank. (I filled this line in, because the lineage is proved.)

(4) When writing dates, follow the genealogical style-- first the day in numbers, then the month in letters, and the full year, such as 6 Feb 1833.

(5) When listing children on the reverse side, put in as much information as you can-- such as spouse's parents. (You may notice in my example that Hiram Allen Soule (#3) was married (3) to his first cousin; also his sister Abigail (#8) married her first cousin James Curtis Soule-- all Soule descendants.)

(6) List your name and address as compiler unless someone else gathers the information. We may need to contact the compiler.

## Man dies in blaze at Masonic Home

An alert assistant administrator and elderly residents who remembered fire-drill instructions were credited Friday with preventing a fire at Union City's Masonic Home from becoming more tragic than it was.

An 81-year-old resident died in the fire, which apparently broke out in his room after he left a cigarette in a lounge chair and went to bed.

Twenty-five of the 300 residents at the stately Mission Boulevard home were evacuated Thursday night when a fire broke out in Arthur Kirkpatrick's room shortly before midnight.

Kirkpatrick died in the blaze. His fourth-floor room at Adams Hall, a modern building behind the main home, was destroyed.

Bernice Jackson, 79, who lives two doors down from Kirkpatrick, was injured when he tried to pull out the fire. He was in stable condition Friday at Washington Hospital, where he is being treated for smoke inhalation.

"The residents were upset, but fortunately we've had fire drills, and they followed instructions perfectly," said J. Burton Brown, Masonic's administrator. "It was all very orderly."

Assistant Administrator Phillip Nichols grabbed a fire hose and started dousing the blaze as soon as he saw smoke billowing from Kirkpatrick's room, according to Union City firefighters. His quick response helped bring the fire under control within 15 minutes.

Nichols later was examined at Washington Hospital in Fremont and released.

On Friday, Brown said he has not decided whether to change any of the Masonic Home rules. At Adams Hall, residents are allowed to smoke in their rooms without supervision, he said: They are warned, however, not to smoke in bed.

Brown said the concrete at Adams Hall and fire walls probably helped confine the

blaze to Kirkpatrick's room.

According to Brown, Thursday's fire was the third at the historic brick home that rests on a bluff overlooking Union City.

About eight years ago, an electric law sparked as workers were remodeling the 90-year-old home, which houses retired Masons and widows of retired Masons. No one was injured or evacuated during that fire, Brown said.

The most recent blaze occurred in 1981 when a wastebasket caught fire.

The Union City fire department, which sent two engines Thursday night, is still investigating the fire. But officials say they believe Kirkpatrick's cigarette started the blaze.

## 74-Year-Old Soulé Steel Calling It Quits

The privately-owned Soulé Steel Co., one of three remaining steelmakers in California, announced a plan of liquidation yesterday.

The Walnut Creek-headquartered company, which operates a modern mini-mill in Carson (Los Angeles County) said industry-wide overproduction, import competition and sharp increases in electrical power costs made the move necessary.

The 74-year-old company, owned by the Soulé family since its founding, fabricates steel reinforcing bars for the construction

industry. Its products were used in the Golden Gate and Oakland Bay bridges, in Embarcadero Center and, recently, in reinforcing the concrete laid for the cable car renovation in San Francisco.

Soulé had revenues of about \$60 million last year and has been marginally profitable for several years, said John Bradsher, a vice president.

The shutdown of the Carson plant is expected by September.

About 300 employees will be laid off.

Last week the company sold its steel fab-

ricating operations in Fresno, Union City, and Sacramento to Judson Steel Corp. of Emeryville for an undisclosed sum. Those operations employ 400.

Chairman Stanley E. Soulé said though substantial recent investments brought the mill to "state-of-the-art efficiency, external forces too great to overcome" were responsible for the liquidation decision.

The two other steel mills in California are operated by Judson Steel in Emeryville and Tamco, a Japanese-American joint venture, in San Bernardino County. Both are also mini mills.

# Law firm's business in liability is an asset

The office looks as if Andy Warhol was the interior decorator: Engine parts, industrial equipment crates and photographs of mangled cars adorn the walls and floors.

Such items are not objects de art, but trophies of courtroom battles fought by Bowman &

Brooke. One of the Twin Cities' newest law firms, it is the only local firm that does nearly all of its work in product liability defense.

The Minneapolis firm's specialization serves as testimony to the growing litigation in this field. The number of product

liability suits against manufacturers has swelled to 11,000 in 1984 from 1,500 only a decade earlier, according to the administrative office of U.S. Courts.

The firm was formed in February 1985 when 14 attorneys, led by Richard Bowman, split away from Gray Plant Mooty & Bennett, a large Minneapolis firm. Bowman had

been a product liability attorney for Gray Plant since 1965 and had developed much of the firm's business in that area, said George Soule, one of Bowman & Brooke's seven partners. Soule left Gray Plant with Bowman, who at 44 is the firm's oldest and most experienced attorney.

The split was as friendly as such things go because the departing attorneys took only product

liability clients with them, Soule said. Other law work, including other types of litigation, estate planning and real estate law, stayed with Gray Plant.

"We were a little island among ourselves" at the Gray Plant firm, said John McShane, a Bowman & Brooke partner. "It was an amiable departure, but I left behind some good friends."

Bowman & Brooke already has grown to 20 attorneys and has an unusually large support staff of 25 employees. That includes a staff of three in Phoenix, where founding partner Jeffrey Brooke represents the state of Arizona against suits claiming that car accidents are the result of poor road design by state highway engineers.

Although more than half the firm's business derives from suits filed in Minnesota, Soule said a growing proportion of comes from outside the state. Its list of clients includes General Motors; Navistar, formerly International Harvester; Clark Equipment and Toyota. Bowman & Brooke often works with the client corporation's legal staff as well as with local law firms when the trial is outside Minnesota.

### New disputes

Soule said his firm has found itself increasingly involved in two new areas of product liability disputes: automobile airbags and all-terrain vehicles.

Bowman & Brooke represents Toyota in all of its airbag cases in the United States. Last year, for instance, Jan Wickstrom sued Toyota for failing to install airbags. Wickstrom, a Twin Cities physician, was severely injured in a head-on collision with a bank robber who was driving the wrong way on I-94 in an attempt to elude a pursuing police car. She contends that her injuries would have been less severe had her car been equipped with an airbag.

Similar cases are being brought against car manufacturers throughout the country.

### Test driving and crash testing are only a minor part of Bowman & Brooke's defense strategy.

"Groups that are devoted to the airbag are starting to fight their battles in court, having lost it in Congress," Soule said.

The popularity of all-terrain vehicles, such as three-wheelers, dirt bikes and other off-road vehicles, also has resulted in a spate of lawsuits.

Bowman & Brooke has been in-

involved in enough of these suits so that some of its attorneys have test driven three-wheelers so they could have a working knowledge of the product. In one all-terrain vehicle suit, Bowman was able to raise doubts about the credibility of a plaintiff's expert witness by getting him to admit he'd never driven one of the vehicles.



Other vehicles Bowman & Brooke attorneys have taken for test drives include helicopters, airplanes, 18-wheelers, oil tankers and bulldozers. The firm also occasionally arranges to have crash tests performed on its client's products.

But test driving and crash testing are only a minor part of Bowman & Brooke's defense strategy. Other defense tactics include:

■ Convincing the jury to give fair treatment to its defendant. Large corporations often are at a disadvantage when viewed next to an injured or grieving individual, Soule said.

"Our biggest obstacle is sympathy for the plaintiff," Soule said. "We talk to the jury about the responsibility to be objective. We don't dispute that the injuries of the plaintiff are horrible. But we advise them that they are responsible under law to treat every litigant equally."

Also working against defendants is the fact that they often are viewed as having deep pockets. Jurors sometimes tend to feel that since the corporation has ample resources to pay damage awards, it should do so even if it's not legally justified, Soule said.

"It takes real guts not to award damages," McShane said.

■ Determining the cause of and circumstances surrounding the incident. Through interviews, the law firm's investigators attempt to establish the physical and mental state of the plaintiff. Sometimes the plaintiff had been drinking alcohol or was asleep at the time of the incident, according to Soule.

"Usually in car accidents you have some time to avert or brake," McShane said. "But not when you're drunk, and you hit going 65 to 70 mph."

McShane often represents General Motors in local accidents involving automobile gas tanks and airplane engines made by its Allison gas turbine subsidiary.

■ Examining the backgrounds and prior testimony of expert witnesses hired by law firm.

Transcripts of prior testimony occasionally demonstrate the expert witness to have contradicted himself, even regarding the product that is on trial. Or, as with

many hired witnesses, the expert may have testified on such a broad range of products that his expertise could be put to question. At the very least, such research helps the defense anticipate the expert's testimony, Soule said.

Bowman & Brooke also lines up its own expert witnesses, first checking their backgrounds to make sure their expertise or credibility is not vulnerable to attack.

■ Researching the development and design of the product. In fact Soule says that many product liability suits hinge on the design of the product.

In researching the product's background, the firm attempts to re-create how the product was developed. They also examine technical journals and competitors' product manuals to assess the state of the art at the time. The firm employs a full-time librarian to aid in such research.

Soule has one case involving an accident in which a Clark Equipment front-end loader rolled over on a steep grade and injured its driver. The driver is suing Clark for not having installed a roll-proof cab that he contends would have protected him from injury.

"The loader was built in 1959, and roll-proof cabs were not a state-of-the-art back then," Soule said.

Soule will attempt to show that Clark was not negligent in failing to install a roll-proof cab because while such cabs are standard features today, they were not when the front-end loader was built.

**Tort reform strategy**

A longer range defense strategy is to convince the state Legislature to reform some of its tort laws to reduce client liability and enable them to better present the client's case.

Although Bowman & Brooke do not serve as hired lobbyists as do some law firms, the firm has been involved in promoting tort reform in the state Legislature. Soule's wife, Janet Soule, is executive director of the Minnesota Defense

Lawyers Association, the opposing counterpart of the Minnesota Trial Lawyers Association. The defense lawyers proposed and supported a tort reform package that was unsuccessful at the state Legislature in the 1986 session.

One tort reform the association

advocates is a law that penalizes drivers and passengers for not wearing seatbelts.

Soule said his firm also wants to be able to use the fact whether the plaintiff was wearing a seatbelt as admissible evidence in court.

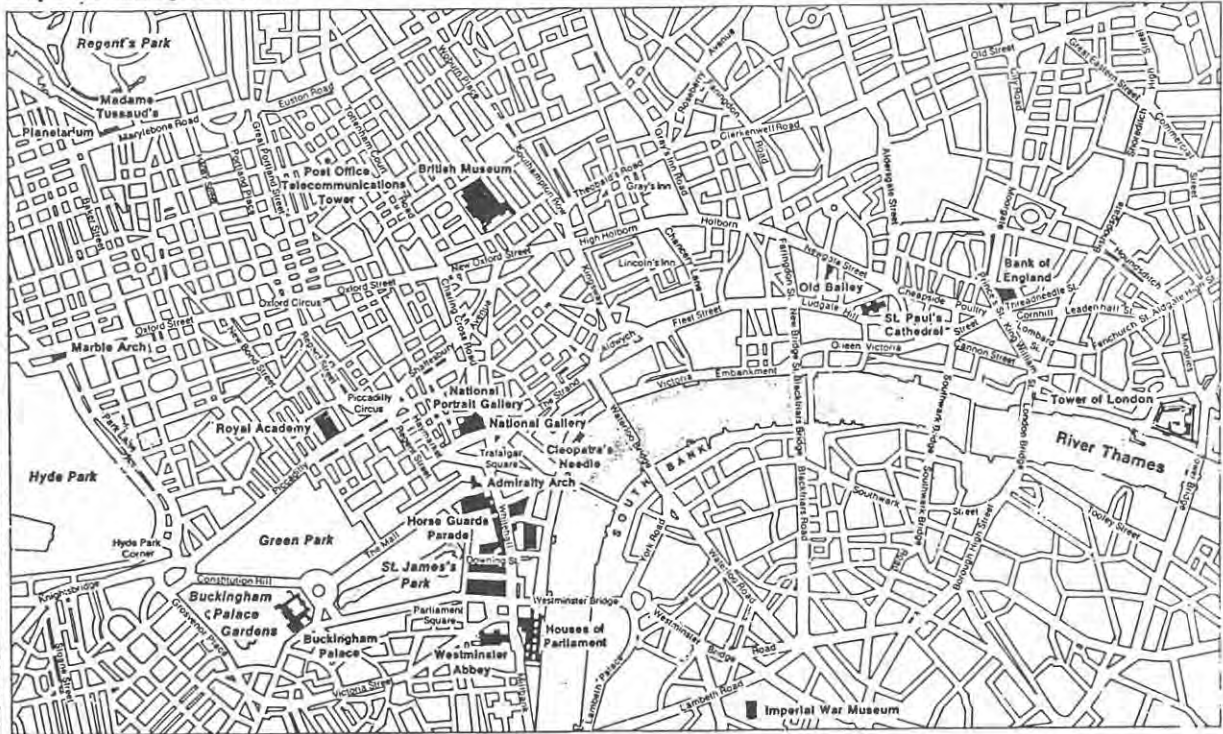
